## Additional Exemplification Details:

- Offered only live on-site.
- Exemplification fee is \$70 per candidate; \$25 for priests, deacons, and seminarians, includes meal.
- The dress code for a candidate for the fourth degree no longer requires a tuxedo. Rather:
  - A candidate will wear a black or dark (blue or gray) business suit, with black shoes, white dress shirt and dark tie. A tuxedo will still be acceptable but not mandatory.
  - A candidate serving in the armed forces of his country, fulltime police and firefighters may wear a Class A or dress uniform.
  - A candidate who is also a priest or deacon may wear clerical attire.
- <u>NOTE:</u> the lowa District has limited scholarship money available to cover the exemplification fee for
  deserving veterans. Send written attestation of need from Faithful Navigator to the District Master prior to the
  date of exemplification.
